# May 28 and June 11, 2024 City Council Meetings

#### **May 28 City Council Meeting**

- Authorized the City Manager to execute a Delegated Maintenance Agreement with the State of California Department of Transportation.
- Rejected all bids associated with the FY23-24 Annual Sidewalk Maintenance Project and directed staff to advertise the project a second time, as well as ensure that local contractors receive notice of the bid opportunity.
- Approved a resolution to modify the Cannabis retail business distance requirements to 1,000 feet from schools only (e.g., preschool through grade 12).
   The Planning Commission was also directed to review zoning of retail Cannabis businesses and provide recommended changes to the Council.

## **June 11 City Council Meeting**

- Adopted a resolution extending service charges imposed on improved real property within the incorporated area of the City of Willows for the use of and/or ability to use the Glenn County Solid Waste System during FY 2024-25.
- Adopted a resolution requesting the Glenn County Board of Supervisors to render specified services to the City of Willows to conduct the City's Municipal Elections to be held on November 5, 2024.
- Appointed Kristel Bettencourt to the Willows Library Board of Trustees.
- Adopted the City Council's final vision, priorities, and goals resulting from the May 1 and 15 Goal and Priority Setting Workshops.
- Authorized the City Manager to execute an agreement with Glenn Groundwater Authority (GGA) for a not-to-exceed amount of \$6,723.31 per year over the next five fiscal years.

# **Council Visioning, Priorities and Goal-Setting Workshops**

On May 1 and 15 of 2024, the Willows City Council engaged in two visioning, priorities and goal-setting workshops in an effort to articulate a clear vision, direction and priorities for the City of Willows over the next one to five years.

The workshops resulted in a <u>clear plan and priorities</u> for moving the City forward,

highlights of which include:

#### **Vision Statement**

Willows is a thriving and safe community where families want to live, work, and recreate. It will foster a proactive business environment that expands other industries, supports its agricultural heritage, and leverages its recreational attractions.

#### **Council Priorities**

- 1. Financial Stability
- 2. Economic Development
- 3. Public Safety
- 4. Community Engagement
- 5. Infrastructure Improvements
- 6. Quality of Life

Achieving the vision will require addressing critical challenges, setting actionable goals, and prioritizing strategic initiatives that align with the Council's vision. At the June 11, 2024, City Council meeting, the final plan resulting from these workshops was presented to and unanimously approved by the Council.

# Financial Sustainability Advisory Committee (FSAC) gets underway!

At the April 23, 2024 meeting, the City Council authorized staff to form a voluntary committee consisting of representatives from local civic groups that serve the Willows



community to discuss and learn more about the status of the city's budget and assist staff with executing the Council approved Education Action Plan regarding City finances.

To date, the Committee has met two times to discuss the City's budget and finances, as well as the Measure I sales tax that will be on the November 2024 ballot. The Committee is currently providing feedback on fact sheets and FAQs regarding the City's finances and the upcoming sales tax measure, as well as recommending additional fact sheets that may be needed to address any absent information regarding the City's circumstances. # City of Willows participates in the 2024 Lamb Derby!


In an effort to increase the public's awareness of the City's current

#### **Annual Pavement and Construction Project**

# **Planning Division**

#### **Tacos Ocampo**

The owner of Tacos Ocampo applied for a Conditional Use Permit to locate a taco truck on the vacant corner lot at West Sycamore and North Plumas Streets. The Conditional Use Permit was continued to the June 19 Planning Commission as additional information was requested by the Planning Commission. If approved, the business will be open from 8 am to 6:00 pm and will serve breakfast, lunch and dinner. The applicant proposes to install concrete across the 150-foot front of the vacant lot adjacent to West Sycamore Street and across 30 feet adjacent to Plumas Street.



# Willows Municipal Code Fun Fact Chapter 9.15 - Curfew Hours for Minors

"Curfew hours" means the period of time commencing at 10:00 p.m. on each day of the week, including Friday and Saturday, and terminating at 6:00 a.m. of the following day.

- (1) A minor commits an offense if he or she remains in any public place or on the premises of any establishment within the city during curfew hours.
- (2) A parent or guardian of a minor commits an offense if he or she knowingly permits, or by insufficient control allows the minor to remain in any public place or on the premises of any establishment within the city during curfew hours.
- (3) The owner, operator, or any employee of an establishment commits an offense if he or she knowingly allows a minor to remain on the premises of the establishment during curfew hours. [Ord. 645-95, 7-11-95. Prior code § 11-201].





The Council recommended no major changes and/or adjustments, the final budget will be presented for consideration and approval on <u>Wednesday</u>, <u>June 26 at 2:00 pm</u> during a Special City Council Meeting.



### FIRE

## Fire Response, Prevention & Emergency Medical Services

#### **Major Incidents**

#### **Aircraft Fire**

On May 12, 2024, the Willows Fire Department (WFD) was dispatched to a mutual aid call in the Kanawha Fire District and responded to a report of an aircraft down in the area of County Roads 65



and D. Willows Firefighters arrived on the scene to a fully engulfed agricultural airplane with fire spreading towards a large diesel tank and other farm machinery. Fire Personnel first cooled down the diesel tank and then extinguished the rest of the fire. The Pilot was treated for injuries by EMS Personnel before self-transporting to the hospital with help from coworkers. The cause of the crash is under investigation.

#### **Residential Structure Fire**

On May 16, 2024, WFD was dispatched to automatic aid in the City of Orland to respond to a residential structure fire. The response included one fire engine, one water tender, and one career firefighter. Units assisted in the search, interior fire attack, and clean up operations. Units were committed to the incident for approximately 2 hours.

#### **Motor Home Fire**

On May 17, 2024, WFD was dispatched to a commercial vehicle fire in the Walmart parking lot. Units arrived to find a fully involved motor home fire threatening other parked cars. Units initiated an aggressive fire attack in an effort to protect nearby vehicles and other potential exposure. While the motorhome was a complete loss, no other vehicles were damaged due to the WFD's rapid response time.

#### **Residential Structure & Vegetation Fire**

On May 19, 2024, Willows Fire units were initially dispatched to a residential structure fire, fire personnel arrived on the scene to find a vegetation fire with exposure to several outbuildings and stacks of wood. Firefighters quickly extinguished the fire and prevented any further threat to the outbuildings. Big "shout out" and "thank you" to the WFD's partners in Artois and Orland Fire Departments for providing rapid mutual aid response.

#### "Bamboo" Fire

On the evening of May 23, 2024, the on duty Fire Captain noticed a large black column

of smoke visible from the fire station and initiated a response to the "Bamboo," a well known homeless encampment. Units arrived to find a large fire of burning trash, debris and vegetation threatening a nearby residential home. Units initiated fire attack and brought the fire under control within 20 minutes and before any damage to the residence could occur. The fire was caused by an illegal cooking fire started by an unknown person. No injuries occurred as a result of the incident.

### **Mobile Home Fire Threatening Adjacent Properties**

On May 23, 2024, units were dispatched to a report of a residential structure fire. Upon arrival, firefighters discovered a well involved mobile home fire threatening adjacent structures and an initial report of confirmed victim entrapment. Units initiated an aggressive fire attack and search of survivable space before transitioning to a defensive operation. Later in the incident, it was confirmed that all victims were able to exit the structure prior to arrival of the Fire Department. Due to high north winds and dry fuels, a second structure further south was threatened from a spot fire. Crews were able to extinguish the spot fire before damage to the adjacent home occurred. The mobile home was a complete loss parked on a vacant rental property undergoing renovation at the time of the incident. The cause of the fire was due to the property owner "sweating" copper pipes during a plumbing repair. The property owner received minor burns during the incident and was treated and released at the scene. No other injuries occurred on this incident, and no residents were displaced. Big "thank you" to Artois, Orland, Bayliss, and Glenn-Codora Fire Departments for their help with extinguishing the fires, as well as to the Glenn County Sherriff's Office, Cal Water and PG&E.

Please let this be a reminder of the importance of defensible space and weed abatement. For example, the adjacent property was undamaged during the fire due to proper clean landscaping. Meanwhile, the home to the south, which did not include defensible space, was damaged due to a spot fire (e.g., a fire that occurs when embers land on the unburned side of a fireline).

#### **New Fire Volunteers!**

avoidance, safety considerations,


emergency medical procedures, fire shelter deployment and other topics.


